

**Village of Ubly  
Council Meeting  
November 4, 2021 @ 7:30 p.m.  
"Approved Meeting Minutes"**

The Village of Ubly Regular Council Meeting was called to order at 7:30 p.m., November 4, 2021, at the Bingham/Village Government Center.

**Attendance:** In attendance were President Jason Nicol, Trustees Brandon Zdrojewski, Gabe Turner, Steve Irvine, Sara Schmidt, Jeff Rubin, Jeff Maurer, Clerk Barb Butch, Treasurer Larry Gornowicz. With excused absences were DPW Supervisor Dave Franzel and Police Chief Dave Rothe. There were 4 in the audience.

**Agenda:** A motion was made by Jeff Rubin seconded by Sara Schmidt to accept the agenda as presented. All in favor, motion passed.

**Communications:** None.

**Clerk's Report:** A motion was made by Steve Irvine seconded by Brandon Zdrojewski to approve the October 7, 2021 Regular Council Meeting Minutes with corrections. All in favor, motion passed.

A motion was made by Brandon Zdrojewski seconded by Gabe Turner to pay the November 2021 bills. All in favor, motion passed.

**Treasurer's Report:** Larry presented the Treasurer's Report. Council accepted the report pending audit.

**Police Report:** Jeff Rubin reported that new tires were ordered for the Charger. The data from the radar that has been up on Washington will be sent to Chief Rothe.

**Public Works:** Working on fall jobs, getting ready for winter. Dave Franzel thanked Jason Nicol for donating his time and equipment to take down the house on Pike St.

**Unfinished Business:**

A motion was made by Gabe Turner seconded by Jeff Rubin approving the Minden City Herald as the Newspaper of Record for the Village. All in favor, motion passed.

**New Business:** Huron County received 6 million in ARPA funds. They are having groups fill out forms and will choose who receives the funds. The Village will try to get funds for the removal of the old Masonic Hall on the corner of Main and Washington Streets and put in a small park in its place. There was also discussion about funding for the storm drains that need to be replaced. Will check on the timeline and bring back information at the Dec. meeting.

**Public Comment:**

Jason informed council that the Village will receive \$82,000 in ARPA funds. A report must be submitted by April 2022 on how the funds are going to be used. The Village will receive half now and the other half in 2022.

Elaine Dropiewski asked if her mother's mailbox that is located on Washington could be moved to in front of her home considering her age and if parking could be limited in front of her home across from the school. There are times her driveway is blocked and she is unable to get out. It was discussed by Council and Jason will discuss the matter with Chief Rothe.

There being no further business a motion was made by Gabe Turner seconded by Jeff Maurer to adjourn the meeting at 8:05 p.m.
