

**Village of Uby
Council Meeting
December 2nd, 2021 @ 7:30 p.m.
"Approved Meeting Minutes"**

The Village of Uby Regular Council Meeting was called to order at 7:30 p.m., December 2, 2021, at the Bingham/Village Government Center.

Attendance: In attendance were President Pro Temp Jeff Rubin, Trustees Steve Irvine, Sara Schmidt, Jeff Maurer, DPW Supervisor Dave Franzel, Police Chief Dave Rothe, Clerk Barb Butch and Treasurer Larry Gornowicz. With excused absences were President Jason Nicol, Brandon Zdrojewski and Gabe Turner. There were 5 in the audience.

Agenda: A motion was made by Steve Irvine seconded by Jeff Maurer to accept the agenda as presented. All in favor, motion passed.

Communications: Before the meeting a plaque was given to Virgil Briolat for his years of service. A motion was made by Jeff Maurer seconded by Sara Schmidt to recognize retired employee Virgil Briolat for his 29 years working for the Village. All in favor, motion passed.

Clerk's Report: A motion was made by Steve Irvine seconded by Sara Schmidt to approve the November 4, 2021 Regular Council Meeting Minutes. All in favor, motion passed.

A motion was made by Sara Schmidt seconded by Steve Irvine to pay the December 2021 bills. All in favor, motion passed.

A motion was made by Jeff Maurer seconded by Sara Schmidt to approve the 2022 Council Meeting schedule. All in favor, motion passed.

Treasurer's Report: Larry presented the Treasurer's Report. Council accepted the report pending audit.

Police Report: Chief Rothe will be presenting radar information at the next meeting. He also wanted to remind everyone that there is no parking on Village Streets from 3 am to 5 am, November thru March. DPW needs the streets clear of obstacles while plowing.

Public Works: Working on winterizing the Pavilion, still cleaning up leaves, Christmas lights are up. Corpro came out and checked the water tower. Snow plowing has started.

A motion was made by Jeff Maurer seconded by Steve Irvine to accept the proposal from Northern Pump and Well on pulling the pump on Well 7 and determining what is wrong. All in favor, motion passed.

Water Administrator Theresa Murdock went over the 3rd quarter water billing with Council. 3 residences were shut off for non-payment but have since then paid their bill and turned back on. Next reading will be around Jan. 1st with 4th quarter bills being sent out shortly after that.
