<u>Trustee Position</u>: Letters of interest for the open Council Seat were received by Aaron LaPonsie and Terry Jimpkoski to fill the seat vacated by Jeff Maurer until the November 2026 election. A motion was made by Jeff Rubin seconded by Sara Schmidt to appoint Aaron LaPonsie to the Council. All in favor, motion carried.

**Agenda:** A motion was made by Sara Schmidt seconded by Tracey Foster to accept the agenda with an addition. All in favor, motion carried.

Public Comment on the Agenda: None.

<u>Clerk's Report</u>: A motion was made by Brandon Zdrojewski seconded by Mitch Holdwickto approve the June 5, 2025, Regular Council Meeting Minutes with a correction: Officer Philip Deacons was hired as a part-time officer. All in favor, motion carried.

<u>Police Report</u>: The cameras for Veterans Park have been installed. Thumb Pest sprayed the Police building for ants. Continuing to work on blight issues. Dave Rothe completed SRO training. The Police Dept. building needs some repairs done. Chief Wood will get quotes for the repairs.

<u>Public Works</u>: DPW has been busy painting curbs, sweeping streets, mowing and spraying.Had to hand clean a few storm drains due to grass clippings mowed onto the street.

Water Billing:2<sup>nd</sup> quarter water bills were sent out the end of June.

<u>Unfinished Business</u>: Council continued discussion on the Basketball/Pickleball courts set up. A motion by Jeff Rubin seconded by Mitch Holdwick to have the Pickleball and Skate ramps on the South Court and move the 2 basketball hoops over to the North Court and paint on new court lines for two courts. All in favor, motion carried.

- c. A motion was made by Brandon Zdrojewski seconded by Jeff Rubin to approve sealing cracks in the streets at a cost of up to \$8000. All in favor, motion carried.

d. A motion was made by Tracey Foster seconded by Jeff Rubinto approve the renewal of the BCBS insurance for Chief Wood. All in favor, motion carried.
