

**Village of Ubly  
Council Meeting  
June 4, 2026 @ 7:30 p.m.  
“Approved Meeting Minutes”**

The Village of Ubly Regular Council Meeting was called to order at 7:30 p.m., June 4, 2026, at the Bingham/Village Government Center.

In attendance were President Jason Nicol, Trustees: Jeff Rubin, Brandon Zdrojewski, Mitch Holdwick, Sara Schmidt and Aaron LaPonsie, Clerk Barbara Butch, Treasurer Larry Gornowicz, DPW Supervisor Vince Kuntze and Water Admin Theresa Murdock. Trustee Tracey Foster and Police Chief Anthony Wood were absent. 6 residents also attended.

**Agenda:** A motion was made by Brandon Zdrojewski seconded by Aaron LaPonsie to accept the agenda with additions. All in favor, motion carried.

**Public Comment on the Agenda:** Treasurer Larry Gornowicz will be checking around on Audit costs.

**Communications:** None

**Clerk’s Report:** A motion was made by Sara Schmidt seconded by Mitch Holdwick to accept the May 7, 2026, Regular Council meeting minutes. All in favor, motion carried.

A motion was made by Brandon Zdrojewski seconded by Jeff Rubin to pay the June bills. All in favor, motion carried.

**Treasurer’s Report:** The treasurer’s report was presented and accepted pending audit.

**Police Report:** The new Taser has been ordered. Police are working on blight issues in the village.

Terry Jimpkoski, Village Representative for the Huron County Ambulance Board reported that the roof has been repaired in Port Austin. There will be an EMS class starting the end of August for anyone interested.

**Public Works:** Vince Kuntze, DPW Supervisor introduced to the Council Nick Booms the new full time DPW Worker. The part time seasonal worker hired is Logan Johnson. Playground equipment has been delivered. Vince thanked Jason Nicol and crew for putting in a new fire hydrant replacing one that was cracked. Nick and Logan have been cleaning up around Veteran’s Park, courts and the Memorial. Training will be in the next couple of weeks on the handheld reader.

Vince asked Council if Joe Weltin could clean up some of the downed trees in the Hoover Farm woods to be used for firewood. Council was fine with him taking any downed trees.

**Water Billing:** There are currently 4 properties that are delinquent on their water bill payments. Shut off for non-payments will be the week of June 8th.

**Old Business:**

- a. Spring dumpsters were available the weekend of May 29-31. It was a huge success with both dumpsters filled up.

**New Business:**

- a. A motion was made by Jeff Rubin seconded by Mitch Holdwick to close Main St. on Thursday, June 25<sup>th</sup>, between Garfield and Pike from 4:30 pm to 10 pm for the Car & Tractor Show and Garfield St. between Main and Bingham St. All in favor, motion carried.

- b. A motion was made by Brandon Zdrojewski seconded by Mitch Holdwick to approve the renewal of the 2026/27 healthcare rate from Blue Cross Blue Shield. All in favor, motion carried.
- c. The 3 year renewal for the Village's yearly audit has been tabled until the July 2 Council meeting.
- d. A motion was made by Jeff Rubin seconded by Sara Schmidt to accept the quote from Michigan Pipe and Valve for water main materials. All in favor, motion carried.
- e. A motion was made by Aaron LaPonsie seconded by Brandon Zdrojewski to approve the quote for gravel for Hund Drive. All in favor, motion carried.

**Public Comment:**

Resident Calvin Messing requested to get a permit for a privacy fence for his property.

There being no further business, a motion was made by Sara Schmidt seconded by Jeff Rubin to adjourn the meeting at 8:08 p.m.
